Ms. Burbidge shared an email from Frank Kirkbride regarding the Lacey Fire District's interest in having a role in the new Lacey museum.

## **OLD BUSINESS**

- a. Depot Trail Amenity. Ms. Burbidge reported:
  - Will be finished by the end of this year unless weather prevents it
  - Construction company owner was injured on another job site. There was concern the project might get behind schedule, but he is back and work has resumed.
  - Soil testing for the playground came back favorable; that project can proceed.
  - A groundbreaking ceremony is planned for November 14 at 12:45 p.m. and the
    Historical Commission is invited to attend. Lacey Rotary is donating \$50,000 for
    their legacy project plus the labor to help install the playground (\$11,000
    value). They have requested a marker at the site (to match the Depot markers) to
    outline Lacey Rotary's history overlaid in some way with Lacey's history.

- Playground timeline. 2019: as much site work as possible. Spring 2020: playground installation. There was discussion re: combining the grand opening of the playground with the depot trail amenity.
- Mr. Tyler would like to be involved when decisions are being made regarding the mat for the playground.

# b. New Museum Project

- Contracts have been finalized with Washington State Historical Society and KMB Architects, and their first deliverable work is underway. Kudos to Erin for working with finance and getting all the invoices organized.
- Staff have weekly meetings with KMB; will report progress to Commission.
- First deliverable is to conduct an analysis on the reuse of the building vs. a new building. A criteria for decision-making was established:
  - Safety
  - Historical factors
  - Cost
  - Environmentally-sensitive areas
  - Environmental & sustainability factors
  - High Ceilings (Will help a small museum feel big and give room for growth in the collections)
  - Climate control adequate for museum purposes
  - Take the most practical and affordable approach; it seems that at least the skeleton should be able to be reused (concrete pad & trusses)

## • Project Timeline:

# A. First 30 Days - Task 1

- KMB reviewed concept plans, pre-submission conference notes, conditions assessments and structural evaluations provided by the City
- Met and reviewed with all consultants (civil, landscape, structural, MEP, LEED, exhibits, and cost estimating). Sub-contractors provide deliverables every Wednesday, KMB meets with City staff every Friday
- Pre-submission meeting with Building Official, City Engineers and Parks & Recreation staff
- Defined deliverable: will provide recommendations and budget level cost estimates for a new structure and renovation of the existing structure for comparison. All estimates will include work for the entire site

- Bus drop off location
- Parking
- Pedestrian Flow
- Outdoor spaces

# C. 5700 Building

- Preparing the building to be solar ready:
  - Unobstructed south facing roof free of rooftop equipment and vents.
  - Extra spaces in the breaker box for a solar dedicated breaker (or go above and beyond and install a dedicated breaker).

- Extra space in the electrical room to wall mount inverters. 2.5" electrical grade conduit leading from the roof to the electrical room.
- Olympia Community Solar model
