CALENDAR OF EVENTS

a. Museum Opening Day target is July 1. Museum staff are installing the new exhibit.

OLD BUSINESS

- a. <u>New Museum Project</u>. Ashley Smith reported that the Salmon Safe Certification was approved and routed for signature. The Lacey Museum will be the first museum certified under this program made possible by Nisqually Tribe funds and a reduced rate from the program. Program advantages:
 - 1. Contributes an additional LEED credit point for innovation.
 - Salmon Safe will support the City in developing and implementing a media outreach strategy for the project certification announcement, which will benefit fundraising efforts.
 - 3. Partnering with Salmon Safe links development of the site to the protection of water quality and imperiled species.

Regarding site archaeology as required for tribal consultation, staff will be meeting to develop the scope of work. The team includes Ms. Burbidge, Ms. Quinn Valcho, Ms. Smith, and Commissioner Thirtyacre. An RFQ is not required; however, if it is over \$15,000, a competitive bid will be required. It is still required to get three quotes in any case, but we can use this effort as one of them.

- b. <u>Lacey Depot</u>. Ms. Burbidge reported that staff began booking weekend reservations on June 1 for July through Sept. dates. We have one reservation on the books for July 31 from 8:00 am 2:00 pm. Community Development is holding a pop up market at the Depot on Friday, June 18 from 11:30 a.m.-1:30 p.m. at the Depot. There will be local farms and other vendors selling their products in addition to food trucks.
- c. <u>Jacob Smith House nomination form update</u>. Ms. Quinn Valcho finished scanning the photographs. She shared a slide show and sent a link to commissioners for access to the images.
