BACKGROUND

The 2020 murder of George Floyd clearly showed that racism and inequities continue to exist in the United States. Floyd's death was one of many that has occurred over centuries in America and under similar circumstances. This event served as a catalyst energizing efforts to eliminate racism and inequities. Many inequities have overwhelmingly and negatively impacted Black, Indigenous, and People of Color. Cities across the United States, like Lacey, established Equity Commissions or Task Forces to help guide efforts to reduce racism and inequities embedded in communities. Commissions are working to create places where ALL community members, regardless of race, gender, age, sexual orientation, disability, English proficiency, among many other identities, have equitable access to opportunities and resources.

Lacey's Commission on Equity is tasked with providing recommendations to the Lacey City Council on ways to:

- Create a more welcoming community for all.
- Continue critical conversations on race and equity.
- Increase involvement from underrepresented community members.
- Identify and remove barriers that prevent full participation in government and public policy.
