- If accepted, Vendor agrees to remit a non-refundable fee of \$175 with three business days.
- Vendor must arrive no later than 2:00 p.m. and be prepared to serve the public by 4:00 p.m.
- Vendors are responsible for following local health, fire, and water quality codes.
- Vendors are required to have Thurston County Health Department certification. Please contact the Health Department at (360) 786-5590.
- All food vendors with cooking equipment must have 40B: C fire extinguishers serviced within one year of event.
- A refuse container of adequate capacity must be present in the concession and its contents properly disposed at the conclusion of the event.
- Washington State Food Service Regulation WAC 246-215-120 Sanitary Facilities and Control states, "Food service establishment owners shall dispose of all liquid waste including gray water, mop water and ice melt into an approved on-site sewage disposal system; or in another manner approved by the health officer."
- No vendor shall assign or sub-lease any part of their concession.
- Vendors not conforming to any of the above requirements will be required to remove concession from the area immediately. No refund provided.

Vendor Agreement and Release of Liability

The applicant and his/her agents, heirs, marital community if any, and legal representatives agree to hold harmless and indemnify the City of Lacey, their officers, employees, and agents from any and all liability, claims and actions for the injury, or death of the undersigned, or the participating spouse, or children of the undersigned, or damage to personal property including animals of the undersigned, arising out of or in connection with the City of Lacey's grant of permission for applicant's participation in the Lacey Fireworks Spectacular and Freedom Concert on July 3, 2017.
